

Christ's Church Academy Student Driving Regulations

Failure to follow driving regulations may result in a minimum one week suspension of driving privileges and/or disciplinary consequences. A student vehicle may be searched if there are reasonable grounds to suspect the presence of illegal substances, stolen property, or other contraband. Driving regulations apply to school functions, even if off-campus. **Please be advised that due to space constraints, student parking is limited to one parking spot per family.**

Vehicle Registration

Student drivers must register their vehicle by submitting the following to the Upper School Administrative Assistant by the end of the first week of school, or upon receiving their driver's license:

- ◆ CCA Vehicle Registration Form (attachment)
- ◆ Copy of driver's license (front and back)
- ◆ Copy of vehicle insurance information

Valid License

Driving to school without a valid driver's license may result in:

- ◆ Car keys being confiscated
- ◆ Vehicle being towed
- ◆ Suspension or expulsion

Parking Lot

- ◆ The speed limit on school property is 5 mph
- ◆ Park on the CCA campus and only in designated parking areas. Please note that student parking is limited and will be available on a first come, first serve basis this year.
- ◆ All registered student vehicles **MUST** display the 2018-2019 CCA parking tag on the rearview mirror. Failure to do so may result in temporary suspension of driving privileges and/or other disciplinary action.
- ◆ Writing or pictures on a vehicle which promote a philosophy contrary to that of CCA are prohibited
- ◆ Do Not: Sit in a vehicle or loiter in the parking lot at any time
Go to the parking lot, or vehicle, or move a vehicle during the school day
Play music loudly

Early Check-Out

Students leaving campus before the end of the school day must:

- ◆ **Have written parental permission**
- ◆ Give the note to the Welcome Center or Upper School Admin Assistant before 1st period
- ◆ Sign the check-out log when leaving campus

The following will result in a minimum one week suspension of driving privileges:

- ◆ Driving to school without having registered a vehicle with the Upper School Office
- ◆ Spinning tires, driving with excessive speed or reckless driving on school property
- ◆ Leaving campus without written parental permission
