### **PAYMENT CHOICES**

We offer the following payment plans that are available for a minimal fee\*. The 12-month plan is scheduled from June 2025 through May 2026. The Quarterly payment plan is scheduled for July, October, January, and April. Tuition insurance of 2.0% (or current provider rate) is required for all monthly or quarterly payment plans and/or utilization of any scholarship or financial aid.

\*Families will be charged a FACTS processing fee depending on the payment plan selected: \$55.00 – Quarterly and monthly payment \*Other FACTS fees include return check fees as well as a set % fee per credit card transaction.

# **Frequently Asked Questions:**

- 1) Why is the school not offering a Pay-in-Full payment plan option for the 2024-2025 school year? Due to almost 98% of our student body utilizing the Step-Up Scholarship program, the Pay-in-full payment plan option is no longer beneficial.
- 2) Why is CCA requiring Tuition Insurance? The insurance program allows families to utilize the claim process to remit tuition fees if a student should withdraw during the school year. Insurance will cover most of the unpaid total tuition, and any unused Step-Up Scholarship funds will follow the student should they apply to another Florida school accepting Step-Up.
- 3) When can I apply for a Step-Up Scholarship for the 2025-2026 school year? Step-Up has not released opening application dates.
